

ORDINANCE NO. 798

AN ORDINANCE ESTABLISHING  
THE POSITION OF AUXILIARY POLICE OFFICERS  
WITHIN THE VILLAGE OF BEECHER

Whereas, the Village President and Board of Trustees believe that certain seasonal events held within the Village mandate the use of additional, sworn peace officers to aid, assist and otherwise supplement the Village's existing police force during certain limited time periods; and

Whereas, the Village believes that the manpower shortage generated can best be obviated by the use of Auxiliary Police Personnel whom are endowed with the same powers and duties of full time, sworn police personnel for limited periods; and

Whereas, the Chief of Police has recommended that the position of Auxiliary Police Officer be created to assist existing police personal during certain seasonal and/or special events as may be determined by the Chief of Police in accordance with demand for same as well as budgetary constraints;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BEECHER AS FOLLOWS:

**Section 1:      AUXILIARY POLICE OFFICER DEFINED.**

For purposes of this section, "Auxiliary Police Officer" is defined in 65 ILCS 3.1-30-20 which said section of State statute is hereby adopted by reference as if fully set forth in this Section 1. Auxiliary Police Officers are further defined as a Peace Officers as described in 720 ILCS 5/2-13.

**Section 2:      APPOINTMENT OF AUXILIARY POLICE OFFICERS.**

The Chief of Police is authorized and empowered to appoint such numbers of Auxiliary Police Officers as may be necessary to preserve and protect the citizens and property within the Village, and otherwise carry out the duties of Auxiliary Police Officers as set forth in Section 5 of this Ordinance.

**Section 3:      QUALIFICATIONS OF AUXILIARY POLICE OFFICERS.**

Auxiliary Police Officers shall meet all applicable criteria regarding State of Illinois certification as police officers, and shall have received a course of training in the use of weapons equal to or greater than that required of all regular, full time police officers

within the Village. No person shall be appointed as a Auxiliary Police Officer if he or she has been convicted of any crime, offense or ordinance violation which involves a felony, crime of moral turpitude, or other manner of offense which may be construed by the Chief of Police as negatively reflecting a candidate's ability to properly hold the position of Auxiliary Police Officer.

**Section 4:**     **DIRECTION, CONTROL AND TERMINATION.**

Auxiliary Police Officers, duly appointed by the Chief of Police, shall be subject to the direction and control of the Chief of Police and exiting rank structure of the Village of Beecher Police Department. Auxiliary Police Officers shall also be subject to all policies and procedures of the Village relating to the performance of the their duties. The appointment of any Auxiliary Police Officer may terminated by either the Chief of Police and/or the Village President, subject to the advice and consent of the Village Board.

**Section 5:**     **POWERS AND DUTIES.**

Any person hired an Auxiliary Police Officer shall have the powers and duties of any full time police officer of the Village only when properly assigned and on duty.

**Section 5:**     **FIREARMS.**

Auxiliary Police Officers shall not carry firearms, except with the permission of the Chief of Police and while in uniform and in the performance of their duties. In no event shall the carrying of firearms be allowed by Auxiliary Police Officers who are no longer employed by the Village.

**Section 6.**     **IDENTIFICATION.**

Identification symbols worn by Auxiliary Police Officers shall be different and distinct than from those used by members of the regular police force.

**Section 7:**     **COMPENSATION.**

Auxiliary Police Officers shall receive compensation for services performed, at such hourly rate as may be from time to time determined by the Board of Trustees of the Village.

**Section 8.**     **PUBLICATION.**

Following the passage and approval of this Ordinance, the Clerk shall publish this Ordinance in pamphlet form.

**Section 9: EFFECTIVE DATE.**

This Ordinance shall be in full force and effect from and after is passage, approval and publication as provided by law.

The present Section 6-6-4 dealing with firearms is hereby amended to read as follows:

**SECTION 6-6-4: FIREARMS:**

Part-time policemen shall not carry firearms except with the permission of the Chief of Police of the Village and then when only in uniform and in the performance of their duties. Provided, however, that the Chief of Police of the Village, may, in his discretion, waive requirements that part-time police officers be in uniform and/or in the performance of their duties in order to carry firearms. Any such waiver by the Chief of Police shall be in writing. In no event shall part-time police officers who are no longer employed by the Village be allowed to carry firearms. This Ordinance shall be in full force and effect immediately after its passage, approval and publication as provided by law. This Ordinance shall be published in pamphlet form as provided by states statute.

line of or upon or along any street, alley or public walk or drive. Such barbed wire fence shall not be constructed through, along, or around any public park, or any land or lots owned or controlled by the Village. Wherever barbed wire is found in use in part or in whole for a fence or barrier in any places as described in this Section, the same shall be removed by the Village.

**SECTION 6-1-11: FIREARMS:**

(A) It shall be unlawful for any person to fire or discharge any gun, pistol, fowling piece or other firearm or any airgun or toy pistol in which percussion caps are used, within the limits of the Village; unless within a licensed shooting gallery.

(B) It shall be unlawful for any person to sell, loan, or furnish to any minor any gun, pistol, fowling piece or other firearm within the limits of the Village.

**SECTION 6-1-12: FIREWORKS:** It shall be unlawful for any person to fire, discharge or set off within the limits of the Village any rocker, fire cracker, torpedo, squib or other fireworks or anything containing any substance of an explosive nature; provided, however, the President may, by proclamation, permit the use of fireworks on the Fourth of July and on such other day or days as he, in his discretion, may deem proper.

**SECTION 6-1-13: GAMBLING:**

(A) It shall be unlawful for any person to set up, keep or maintain or permit to be set up, kept or maintained in any house or place within the corporate limits of the Village, occupied or controlled by him, any E.O., A.B.C., roly-polly, keno or faro table, faro bank, roulette or other instrument or
